History

In the year 2000, a few passionate individuals in Bengaluru came together with a simple idea – to support, encourage, and promote the NGO community. The intent was to enable training, provide opportunities to raise funds, and connect them to individuals and organisations, who wanted to engage with the NGO sector.

Thus was born India Cares (erstwhile 'Bangalore Cares Trust').

In 2008, we registered and increased our support to the NGO sector by associating as the Philanthropy Partner of the World 10K Run. We then supported various initiatives associated with the Daan Utsav – India's 'Joy of Giving Festival'. In 2014, we expanded our services to Delhi and the NCR region, serving as the Philanthropy Partner for the Airtel Delhi Half Marathon.

We remain relentless in our mission to support the NGO sector.

We emphasise participation in public events

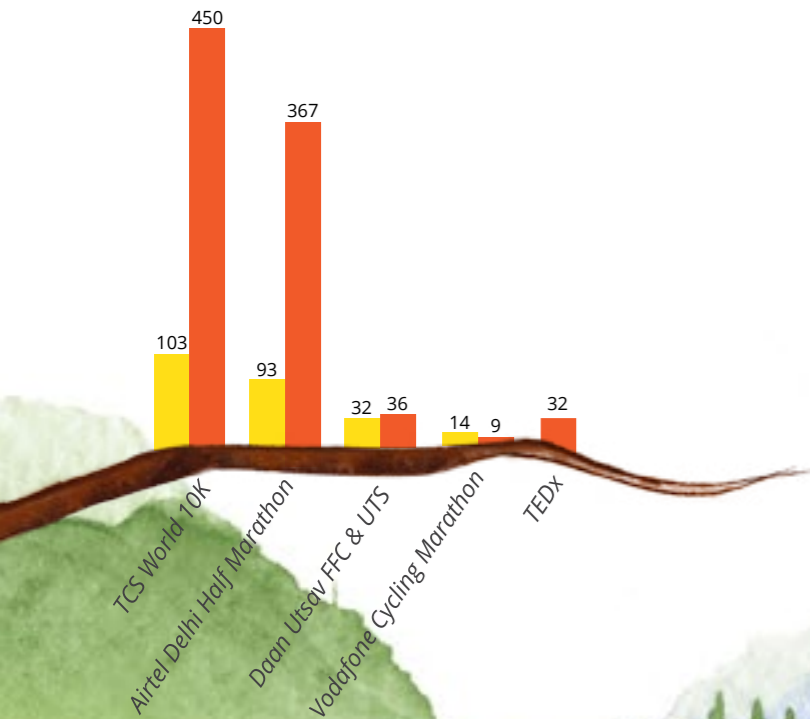
At India Cares, we understand that NGOs need increasing resources to continue being a pillar of support for society. For this reason, we extensively use events to help promote the good work of NGOs.

Why events, you ask? Events create opportunities for everyone inside and outside an organisation to be involved – board members, staff and volunteers, companies and employees, individuals and their families. Events provide a platform for causes to be visible to the public.



India Cares helped 192 NGOs to:

- Enhance their ability and confidence to reach out to the public
- Improve their visibility in society
- Demonstrate financial transparency by showing their willingness for public scrutiny

Our association with events has grown.

Airtel Delhi Half Marathon (ADHM):

This prestigious event began in 2005. In July 2014 we established an office in Delhi and became the Philanthropy Partner for ADHM. 92 NGOs registered for the race on 23 November 2014. 71 NGOs raised ₹3.67 cr.

TCS World 10K, Bengaluru:

In our eighth year of partnership with the World 10K event held on 17 May 2015, we helped 83 NGOs raise ₹4.5 cr.

Other Initiatives

We were the 'Fiscal Partner' for the TEDx Bengaluru talks held in August 2014.

Our association with Daan Utsav – India's festival of giving – continued in October with the events 'Food for Change' and 'Under the Stars'.

Two new corporate events held in Bengaluru helped raise a total of ₹17 L for 17 NGOs:

- **Deutsche Bank's internal Cricket Tournament** (February 2014) raised ₹8 L for three NGOs
- **Vodafone Cycling Marathon** (March 2014) raised ₹8.6 L for 14 NGOs

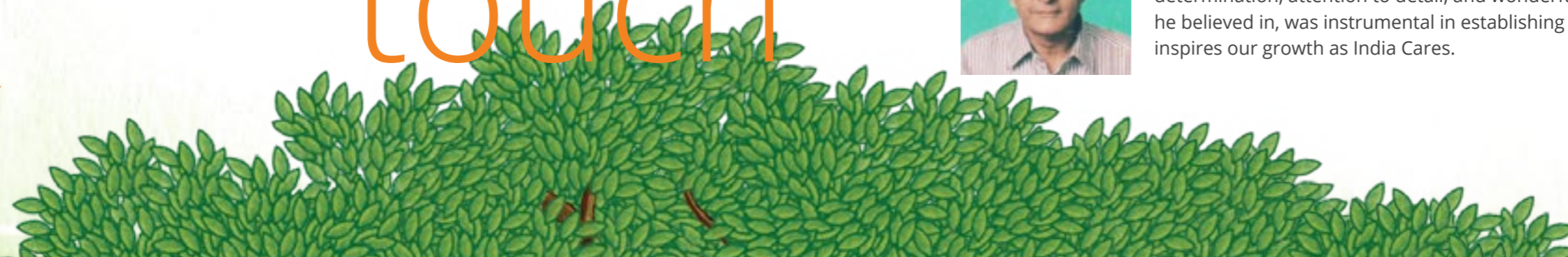
